UMOM NEW DAY CENTER EMERGENCY SHELTER PROGRAM SERVES HOMELESS FAMILIES. IN ADDITION TO PROVIDING FOR BASIC NEEDS OF FOOD, SHELTER AND CLOTHING, RESIDENTS HAVE ACCESS TO COMPREHENSIVE SERVICES TO HELP THEM END THEIR HOMELESSNESS WHICH INCLUDES: WORKFORCE DEVELOPMENT AND TRAINING FOR ADULTS, CHILD CARE, AFTERSCHOOL PROGRAMS, CASE MANAGEMENT, HOUSING SERVICES, AND HEALTHCARE. IN FISCAL YEAR 15/16 UMOM'S TWO FAMILY SHELTER PROGRAMS SERVED OVER 400 HOUSEHOLDS WITH CHILDREN TOTALING MORE THAN 1,400 INDIVIDUALS. UMOM HAS THE CAPACITY TO SERVE 82 HOUSEHOLDS WITH CHILDREN IN EMERGENCY SHELTER AND 48 MORE HOUSEHOLDS IN EXTENDED SHELTER/TRANSITIONAL HOUSING.

UMOM NEW DAY CENTERS HAS AN ARRAY OF HOUSING PROGRAMS DESIGNED TO MEET THE NEEDS OF AT-RISK FAMILIES. UMOM'S AFFORDABLE HOUSING PROGRAMS INCLUDE RAPID RE-HOUSING AND PERMANENT SUPPORTIVE HOUSING FOR FAMILIES. IN FY 15/16 UMOM HAD THE CAPACITY TO SERVE 125 FAMILIES IN THE RAPID REHOUSING PROGRAM AND 61 FAMILIES IN PERMANENT SUPPORTIVE HOUSING. ADDITIONALLY, UMOM HAD THE CAPACITY TO SERVE 72 VETERAN HOUSEHOLDS WITH RAPID REHOUSING THROUGH THE SUPPORT SERVICES FOR VETERAN FAMILY GRANT. PERFORMANCE DATA INDICATES THAT AT LEAST 89% OF THE HOUSEHOLDS RECEIVING RAPID REHOUSING SUPPORT WERE ABLE TO SUSTAIN THE PERMANENT HOUSING UNIT AFTER UMOM'S ASSISTANCE CONCLUDED.

THE WATKINS OVERFLOW SHELTER PROGRAM PROVIDES SAFE SHELTER FOR 145 SINGLE WOMEN AND 17 FAMILIES EACH NIGHT. THE CITY OF PHOENIX OWNS THE FACILITY AND UMOM WORKS IN PARTNERSHIP WITH THE CITY OF PHOENIX IN PROVIDING THESE SERVICES. IN ADDITION TO HAVING A WARM PLACE TO SLEEP, PROGRAM PARTICIPANTS ARE PROVIDED MEALS, HYGIENE ITEMS CLOTHING AND MEDICAL ATTENTION, AS WELL AS HOUSING-BASED CASE MANAGEMENT AND OTHER SUPPORTIVE SERVICES PROVIDED BY UMOM.
